### 2021-1st Songdo Dormitory Housing Application Guidance

(For Non-RC Students only)

We would like to inform you of the matters to be aware of when applying Songdo Dormitory due to COVID-19.

- 1. We inform you that the admission to Songdo Dormitory for the 2021-1 semester has been **completely canceled** due to the non-face-to-face class of Yonsei headquarters taking into account the COVID-19 situation.
- 2. However, in accordance with the principle of minimizing the number of residents in the dormitory, application is allowed exceptionally after reviewing the attached matters only in the following cases.

- \* Precautions for submission documents(If the following matters are not complied with, application may be deleted due to insufficient documents)
  - The form is PDF and if there are multiple documents, merge them into one PDF file and upload them.
  - Do not \* mark all members' names
  - Except for the first digit of the resident registration number(date of birth), the second digit is issued with a \* mark or deleted in black and attached.
  - Attachment validity: Issued after 2021. 1. 1.(Fri)
  - It will be deleted from the application if the documents are incomplete, false documents, or false information is confirmed.

#### 3. Other Precautions

- A. In order to minimize the risk of COVID-19 infection, you can only apply for 1 person per room. (Reflection of instructions by CDSCHQ.)
- B. If quarantine occurs due to overseas entry, there will be a separate cost.
- C. You must agree to the Attachment's 'Compliance Pledge for Prevention Rules of COVID-19'.
- D. COVID-19 test results must be submitted. (For students residing in Korea only)
  - Results of test conducted within 5 days(excluding weekends and holidays) of the check-in date
  - Search 'Selection Care Center' on <a href="http://ncov.mohw.go.kr">http://ncov.mohw.go.kr</a> and check local 'Selection care Center'.
  - Individuals are responsible for the cost of test.
- E. While living, you must log in to the 'COVALT app' every day and record without lies.
- F. Matters related to joining Songdo Dormitory may change depending on changes in the COVID-19 situation.
- 4. If the lecture method is changed to a face-to-face class in the future, we will notify you of additional application related information.

- A. In the case of 1 persons per room, the dormitory fee for double room is applied.
- B. The facility deposit will be refunded to the account which has been registered, <u>please make</u> sure to register the bank account for the refund from the beginning of the new semester.

- C. The cost of meals is not included in housing fee. Please purchase it personally at the restaurant after the move-in.

#### 6. Information for Move-In

#### A. Move-in Procedure

- (1) Confirm your identification at each reception when you check in.(ID cards required.)
- \* Only you can enter the dormitory, and parents, family members, etc. cannot enter the dormitory.
- (2) Submit the Immigration certificate(or real passport), Chest X-ray results(for tuberculosis test), Certificate of MMR(Measles, Mumps & Rubella) Vaccination, COVID-19 test results(Only Domestic residents(residing in Korea)), Compliance Pledge for Prevention Rules of COVID-19
- (3) Check your assigned room, get a card key.
- (4) After the beginning of the new semester, Please submit facility check list on the Songdo dormitory homepage(https://yicdorm.yonsei.ac.kr).
- B. Internal facilities: desk & chair, wardrobes, shoe closet, single bed & mattress, individual air conditioning & heating system, shower room, toilet, LAN port
- C. Required personal items to move-in

- (1) ID card(for the ID confirmation)
- (2) Personal belongings(mattress sheet for a single bed size(1,000\*2,000, height 200), bedding, pillow, toiletries, clothes hangers, slippers and etc.)
- \*\* Please make sure to keep the personal belongings in a proper level due to the fact that dormitory is a place for the communal living.
- \* Size of wardrobes: 280\*2,100 for a triple room, 600\*2,100 for a double room
- D. All electronic heating devices are not allowed to use in the room.

#### (except for a hair drier or straightener)

- E. No pets are allowed in the dormitory.
- F. How to get a delivery: receiving with a signing in person at each building lobby
- \* Be sure to exclude your valuables from the delivery in case of losing it.
- \*\* Please dispatch the delivery after confirming the assigned building and room number from the assignment which will be noticed on 17th, August on the Yonsei Portal.
- \* Address for the delivery: Room #, Bld. #, Songdo Dormitory #, Yonsei International Campus, Songdo Gwahakro 85, Yoensu-gu, Incheon.

#### 7. Submission of Medical Certificates

- A. All students who are willing to move into the dormitory must submit 'Chest X-ray results(for tuberculosis test)' and 'Certificate of MMR(Measles, Mumps & Rubella) Vaccination'.(only Korean and English versions are valid.)
  - (1) tuberculosis(TB) inspection certificate
    - ① TB inspection should be done in the hospital
    - ② TB inspection must not go over expire date(within 3 month from a date of issue)
    - 3 TB inspection certificate must be submitted every semester
    - ④ CD, film etc. cannot be submitted instead of the certificate(Only the document of certificate with the seal can be submitted.)

\* Those who have already submitted the MMR certificate before do not need to submit it again.

- (2) MMR (Measles, Mumps & Rubella) Vaccination Certificate : A certificate of  $2^{nd}$  vaccination is valid.
- (3) COVID-19 test results(Domestic residents(residing in Korea) only)
  - ① Results of test conducted within 5 days(excluding weekends and holidays) of the check-in date
  - 2 If the test determines that community life is impossible, application will be cancelled.
- B. Move-in is only available if both documents are submitted at the time of checking in. If one of those document is not prepared, move-in is basically not allowed on that day of arriving.
- C. The term of validity for the Chest X-ray Certificate: within 3 months from the Move-in date.
- D. Where to submit: at the reception desk in the lobby on the very day of move-in.

- A. The housing application can be completed only if every item in the form is filled without fail. (If not, the application is not fully finished.)
- B. Canceling the application for personal circumstances or an registration of other universities after

the payment, please download and fill 'the Refund Application' form from the website (https://yicdorm.yonsei.ac.kr → Community → Form reference) and send it via email to residence@yonsei.ac.kr until 2021. 2. 18.(Thu) 17:00. Once the move-in procedure is finished, housing fee will be refunded by the terms of mid-departure regulations.

- C. Refund for the mid-departure students will be repaid after deducting 150,000 won on the housing fee and the extra will be refunded after calculating by day remained staying period (No refunds after 2021. 5. 31.(Mon).
- D. In case of the leave of absence or dropout in the middle of the semester, staying in the dormitory is not allowed for the rest of the residence period.(<a href="mailto:move-out">move-out</a> is supposed to be progressed with applying a leave of absence or dropout at the same time.)
- E. Students who want to use the dormitory during the vacation period must apply separately, and will be assigned to move to designated area.

- \*\* Applying a violation of the rules are 'Songdo Dormitory Regulations of COVID-19
